2. Tracy Short – Partnership Opportunity

O Tracy presented her project from Champaign Leadership called "Walk Across Champaign". The program would consist of community members creating teams of 4-8 people and would last about 4 weeks. During that time the teams would have to walk 26 miles (about a mile a day) which is the distance Champaign County is across. Participants would keep a walking log and turn it in at the end. The closing event could be at Healthy Kids Day. The top school would receive money for their PE program and the top 2 teams would receive \$100 gift cards. Tracy is looking for partnership with the program to start development of a workable version of it. The group agreed to have Tracy join as a member and a subcommittee (also the 5210 committee of Stacey, Elaine, and Jennifer) would begin work on it.
